

May 3, 2012

The Codorus Township Board of Supervisors met on May 3, 2012 at 7:30 P.M. Board members present were: Lamar Glatfelter, Robert Gladfelter and Brian Kaltreider. Others present were: April Rehbein, Randy Sterner, Jim Holley, Annette Grzymala, Allen & Marilou Redding and Neal Leatherman.

The meeting opened with the pledge to the flag.

The bids for Shaffers Church Road paving projects were opened and read as follows:

Bid # 1- Provide and place 2" 19 mm Superpave, approximately 400 tons on Shaffers Church Road from Parrish Road to Buffalo Valley Road

Stewart & Tate bid \$71.05 per ton for a total bid of \$28,420
Bituminous Paving bid \$56.85 per ton for a total bid of \$22,740
Kinsley Construction bid \$64.00 per ton for a total bid of \$25,600
Shiloh Paving bid \$68.29 per ton for a total bid of \$27,316

Bid # 2- Provide and place 2" 19 mm Superpave, approximately 900 tons on Shaffers Church Road from Messersmith to Greenmount Church Road,

Bob made a motion to award Bid # 1 & Bid #2 to Bituminous Paving, seconded by Brian. The motion carried. Vote 3-0.

The bids for 40,000 gallons of CRS-2 were opened and read as follows:

Bob made a motion to award the bid to Stewart & Tate, seconded by Lamar. The motion carried. Vote 3-0.

Brian made a motion to award the bid to Vulcan Materials, Bob seconded the motion. The motion carried. Vote 3-0.

Bob made a motion to award the contract to Alpha Space, seconded by Brian. The motion carried. Vote 3-0.

Quotes were read for 6,500 gallons of calcium chloride delivered and spread as follows:

JMG quoted .939 per gallon
Recon Construction quoted 1.13 per gallon
Calcium Chloride Sales quoted 1.10 per gallon

Bob made a motion to award the contract to JMG, Lamar seconded the motion. The motion carried. Vote 3-0.

Randy Sterner gave a report on the quarterly Emergency Management Meeting.

Annette Grzymala was before the board regarding a violation notice she received from Peter Schilling. She has two horses on her property and does not have 1.5 acres of land. Annette had horses on the property in 2004 but removed the horses and the fence in 2009. The Township passed ordinance # 09-01 on April 8, 2009. The ordinance prohibits livestock on lots that are less than 1.5 acres in size. Annette would like a variance to keep the horses. She was told that she would need to apply for a zoning hearing since this Board cannot grant variances to the zoning ordinance.

Allen Redding presented a plan for an add on subdivision and maintenance agreement. Bob made a motion to approve the plan, seconded by Brian. The motion carried. Vote 3-0. Lamar made a motion to approve the agreement, seconded by Bob. The motion carried. Vote 3-0.

Jim Holley presented a two lot subdivision plan for Rene DeBrabander. Two waivers were requested. S.404.A.4 contours at vertical intervals of 5 ft and s.404.A.3 plan oriented so top of map is due north. Brian made a motion to grant the waivers, seconded by Bob. The motion carried. Vote 3-0. Bob made a motion to approve the plan, seconded by Lamar. The motion carried. Vote 3-0.

The bills were presented to the Board. Bob made a motion to pay the bills, seconded by Brian. The motion carried. Vote 3-0.

The meeting adjourned at 10:00 P.M.
