

November 11, 2015

The Codorus Township Board of Supervisors met on November 11, 2015 at 7:30 P.M. Board members present were: Lamar Glatfelter, Bob Gladfelter and Charlie Van Scoyoc. Others present were: April Rehbein, Carolyn & Steve Bupp, Brian Kaltreider, Dave Rehbein, John Amspacher, David Tuten, Mark Easterling, Aaron Grieb and Attorney Herrold.

The meeting opened with the Pledge to the flag.

The minutes were approved as presented.

Steve Bupp reported that the Krebs Road sign at the corner of Krebs & S.R. 616 is missing. He also reported that he has seen work going on at the former Wildasin property on Seven Valleys Rd. Steve also said he saw a jeep driving through the wetlands on Seven Valleys Road and dragging mud out onto the roadway.

Carolyn Bupp had questions about the Joint Sewer Authority Bond that was talked about at the last meeting. Attorney Herrold explained that if the Joint Sewer Authority cannot repay the loan it would fall back on Codorus Township and Jefferson Borough.

Mark Easterling asked if there had been any discussion on the road studies that were requested. Bob Gladfelter reported that the studies were already done several years ago.

Aaron Grieb was present. He is interested in a position on the Township Recreation Board.

David Tuten is the Township Representative for the Glen Rock Library. He is resigning from the position. The Library would like to have a new representative from Codorus Township.

Attorney Herrold reviewed the Defined Benefit Plan Statement for the Township Pension Plan that sets forth the objectives of the plan and the allocation of the assets.

Bob made a motion to authorize Lamar to sign the Defined Benefit Plan Statement, seconded by Charlie. The motion carried. Vote 3-0

The Floodplain ordinance is ready to be advertised for adoption at the meeting on December 9, 2015. Lamar made a motion to authorize Attorney Herrold to advertise the ordinance. Charlie seconded the motion. The motion carried. Vote 3-0.

Jerry Lucabaugh's term is up on the Zoning Hearing Board 12-31-2015. Lamar made a motion to appoint Jerry to another term. Bob seconded the motion. The motion carried. Vote 3-0.

Cecile Fetter's term is up on the Recreation Board 12-31-2015. Bob made a motion to appoint Aaron Grieb to the Recreation Board. Charlie seconded the motion. The motion carried. Vote 3-0.

The bills were presented to the Board. Bob made a motion to pay the bills, seconded by Charlie. The motion carried. Vote 3-0.

The meeting adjourned at 8:20 P.M.
