

December 8, 2021

The Codorus Township Board of Supervisors met on December 8, 2021 at 7:30 PM. Board members present were: Lamar Glatfelter, Bob Gladfelter and Charlie Van Scoyoc. Others present were: Michael Wickham, Harvey Kornstein, Attorney Andrew Herrold, Brandon & Karen Wright, Aaron Stoltzfus, Adny Snyder, Steve & Carolyn Bupp and Corporal Sweeny from the PA State Police.

The meeting opened with the pledge to the flag.

The minutes were approved as presented.

Corporal Sweeny from the PA State Police asked if anyone had any questions or concerns for him. Lamar commented that there are a lot of speeders on S.R. 516 and Shaffers Church Rd. Michael Wickham commented that there are a lot of heavy trucks on Snyder Mill Road. The road is posted no trucks. Mike said the trucks are on the road from 5:30 AM – 11:00 PM.

The junkyard licenses for Amspachers and Lucky's were presented to the Board. Charlie made a motion to sign the licenses. Bob seconded the motion. The motion carried. Vote 3-0.

Attorney Herrold said he has spoken to Comcast regarding service in the Township. Comcast has sent maps showing where there is service and where they might be adding service. Comcast is willing to call into a meeting at a later date to discuss this.

Attorney Herrold spoke to the Board regarding some changes to the Sunshine Act. Agendas need to be posted 24 hours in advance of the meetings. The comment periods have remained the same. Executive sessions have remained the same. Public comment period can be at the beginning or the end of the meeting.

The 2022 budget was presented to the Board. Lamar made a motion to approve the budget. Bob seconded the motion. The motion carried. Vote 3-0.

Lamar reported that there will be a disc golf tournament at the park on January 16th. Lamar said the small soccer field is still in bad shape and probably won't be ready for use this spring.

The bills were presented to the Board. Bob made a motion to pay the bills, seconded by Charlie. The motion carried. Vote 3-0.

Michael Whitcomb had a complaint about Ross Paving operating a high impact business on Snyder Mill Road. He said they are doing damage to the road with heavy dump trucks.

Harvey Kornstein is concerned about the dump trucks speeding on the road. Harvey said there are children living on the road.

Michael & Harvey were told that the Zoning Officer has been alerted to this issue. Attorney Herrold stated the process to a violation is a notice is sent. The property owner can appeal this to

the Zoning Hearing Board. There are legal requirements that need to be followed. If they do not appeal to the Zoning Hearing Board the Zoning Officer can file with the Magistrate. Attorney Herrold will check in with Eric Swiger to see where this stands.

The meeting adjourned at 8:30 PM
