The meeting was called to order by the president, Ralph Gladfelter at 9 A.M.

The Bills were presented to the board.

Ralph Gladfelter made a motion to pay the bills. Motion second by George Smith.

Mrs Bathon presented plans for three building developments. Ralph Gladfelter made a motion to approve one lot on each plan. Motion second by Paul Dehoff. The following lots were approved: Chestnut Ridge lot #8 section B. No 1 lot along hill climb road. and lot no 7 in section 'A' of Chestnut Ridge.

George Smith made a motion to reimburse Tampest and Marie Folkenroth for their 1971 duplicated tapes. Motion second by Ralph Gladfelter.

The Junk Yard Ordinance was presented to the board. The planning commission recommended the board to approve the Ordinance with the following changes to exclude items 'C' and 'F' of section 14 and to change the fee from \$200.00 to \$100.00. Ralph Gladfelter made a motion to approve the Ordinance. Motion second by George Smith.

The following tax structure was set up for budget purpose. Paul Dehoff made a motion to retain the \$5.00 Per Capita Tax. Motion second by Ralph Gladfelter.

Ralph Gladfelter made a motion to levy a 9 mill real estate tax, and to set aside 2 of the 9 mills for major equipment repairs or (over \$500.00) or new equipment. motion second by George Smith.

Paul Dehoff made a motion to Retain the 1/2 % Earned income tax. motion second by Ralph Gladfelter.

George Smith made a motion to Retain the 1/2 % Real estate transfer tax. motion second by Paul Dehoff.

Ralph Gladfelter made a motion to adjourn at 11.25 motion second by Paul Dehoff.
